

## Covenant and Design Review Guidelines Violations Enforcement Policy

The Covenants and Design Review Committee (DRC) guidelines exist to assure property owners that the Asheton Park at Northlakes neighborhood is constructed and maintained with quality homes, buildings, and yards: that are architecturally and aesthetically pleasing and harmonious with surrounding structures and topography; and that have landscaping and other site improvements consistent with the aesthetic quality of Northlakes as a whole. Any exterior change to your home or yard <a href="https://www.ashetonparkhoa.com">REQUIRES</a> a Design Review Committee approval. Procedures can be found on the website under the Design Review Tab.

The Asheton Park Property Owners association's authority to enforce the covenants and guidelines is described in the *Articles of Enforcement* section beginning with paragraph 11.

The Property Owners Association is willing to work with owners who have been notified of violations to resolve the problem. However, to work together, property owners must be willing to open a civil dialogue and communicate any extenuating circumstances related to the reported violation. All residents will be afforded an opportunity to address the HOA board of directors regarding any covenant violation notice, but it is the owners responsibility to request a meeting with the board.

All costs (legal and administrative) associated with the administration and enforcement of fines will be added to the fine totals and billed to the owner. Failure to pay fines will result in a lien being placed on the owner's property and/or possible legal action. Payment of fines does not absolve or negate the requirement to comply with the corrective action required by the HOA or to comply with the covenants and guidelines for the assessed violation or any other violations in the future. The following will be established as <a href="mailto:example-fines">example</a> fines for the most common violations; however, the association reserves the right to alter any fine on a case-by-case basis and with board approval.

- 1. Recreational Vehicles/Equipment Stored or Parked: \$100 per day until removed.
- 2. Not submitting a DRC Project Review Request Before Changes: \$1000
- 3. Unapproved Exterior Remodeling: \$5,000-\$10,000.
- 4. Unapproved Landscaping: \$1,000-\$5,000.
- 5. Unapproved Fencing: \$5,000
- 6. Unapproved Structures: \$10,000

We are serious about protecting your property values. The key to avoiding fines is to know the covenants and guidelines and communicate with the HOA. If you are unsure whether something is allowed, ask. **SUBJECT:** Cease and Desist Notification

We have sent two previous notices notifying you of a covenant violation on [DATE] & [DATE]. There has been no communication with the HOA on this issue. Therefore, the HOA has no choice but to proceed with Step 3 of the Covenant Violation Policy established by the Asheton Park Board of Directors.

**Payment:** In accordance with paragraphs 11.01-12.01 of the Asheton Park Covenants, all subsequent legal and administrative costs associated with the enforcement of this violation will be <u>added</u> to the fine totals and billed to the homeowner.

**Failure to Pay:** *In accordance with paragraph 11.01(i),* failure to pay assessed fines will result in a lien being placed on your property. Additionally, pool privileges will be revoked until payment of all fines and the required action is complete.
